## MEMORANDUM OF UNDERSTANDING (MOU)

and

Department of Physics, A.D.P. College, Nagaon, Assam.

This "Memorandum of Understanding" (MOU) is made and executed of this ...Q6.7.Q6.7.2023.between Nagaon Gopi Nath Dev Goswami Commerce College having its registered office at Panigaon, Nagaon, Assam hereafter called NGNDGCC or Party A and Department of Physics, A.D.P. College, Nagaon, (Assam) hereafter called Party B.

<u>Purpose</u> – This "MOU" is entered for the purpose of promoting the goals of both parties hereafter referred to as Party A and Party B established relations and co-operation for promoting mutual understanding for the use of Class Room and Laboratory of Physics Department, A.D.P. College Nagaon. As such the "MOU" sets the terms and understanding between the two parties.

## Responsibilities -

Now in consideration of the mutual promises and covenants contained herein the parties agree as follows:-

- To facilitate opportunities for faculty exchange between Party A and Party B.
- > To agree to bear the travelling expenses of outgoing staff by Party A in case of sending its staff to Party B and viceversa, unless mutually agreed otherwise.
- To promote co-ordial relationship between the Party A and Party B.
- > Specific agreements for special facilities will be agreed upon by both parties in advance.
- Visiting staff may be authorized to teach schedule classes in its academic term at the host College in the area of their expertise.
- Any controversy, dispute or deference in relation to this MOU, shall be resolved amicably by both parties.
