Nagaon Gopinath Dev Goswami Commerce College is the only full-fledged institution of higher education in commerce, in the entire Central Assam region. The College came into existence on 24th September, 1984 in the premises of Sankardev Natya Chora under the name of Nagaon Commerce College. It was renamed as Nagaon GNDG Commerce College after the name of Late Gopinath Dev Goswami, an illustrious son of Nagaon and was shifted to its present site at Panigaon, Nagaon in 1989. The College owes its existence to the pioneering and tireless work of its founder president Late Ratnakanta Bora, Rtd. I.A.S. and the founder-Principal Sit. Kamal Chandra Goswami and the generous donations of the family of Late Gopinath Dev Goswami. IDENTITY CARD

For attention of Guardians and Students:

- Please go through the prospectus carefully before signing the Admission Form.
- Students will be selected strictly on the basis of merit.
- Seats are reserved for students belonging to SC/ST/MOBC/OBC/Physically handicapped as pergovt. Rules.
- Admission to the College Hostel will be on the basis of merit after the college admission.

The following documents should be produced at the time of admission:

Original Marksheet, Certificate of the last qualifying examination, Caste Certificate, Gap Certificate if any. Provisional certificate will not be accepted.

Income certificate of parents must be produced if opting for free admission scheme of Assam government.

Filling up the registration form immediately after the admission is mandatory for registration under G.U.

All the internal and sessional examinations and assignments are a part of the university examinations and are conducted according to university guidelines. 75% attendance is compulsory to qualify in the sessional examination.

Eligibility Criteria:

B.Com: Candidates who pass H.S.(10+2) Examination in Science / Arts / Commerce under SEBA/AHSEC/CBSE with at least 50% are eligible to apply.

Admission to the college is strictly on the basis of merit. But there is reservation for candidates belonging to S.C./S.T./ PWD/OBC/MOBC Categories.

The candidates selected for Degree Course must get themselves admitted on the very day of the interview. Failure to turn up at the interview will forfeit the claim for admission. The date of commencement of the new classes is announced after the admission.

B.Sc.: Candidates securing 50% and above marks secured in H.S. (10+2) Exam in Science under SEBA/CBSE/AHSEC can apply

M.Com.: Students passed in the Common Entrance Test conducted by GU only can apply for M.Com Regular Courses.

BBA: Candidates who pass HS10+2 Examination in Arts, Science or Commerce under AHSEC or from any other Board or Council recognized by Gauhati University securing at least 45% marks or who pass the 3 years diploma course in Engineering recognized by the G.U with at least 50% are eligible to apply.

KKHSOU: (i) BA (ii) Tourism and Hospitality Management. (lii) B.Com

- Students who passed 10+2 in Arts or Commerce stream
- Those completing 18 years of age on 1st July in the given year of admission.
- Any drop out candidate may take admission in the said programmes.

Girls' Hostel : Nagaon GNDG Commerce College has a girls' hostel with a capacity of housing 38 boarders at present. Admission to the hostel is strictly on the basis of merit.

Scholarships, Prizes etc:

The College office helps and guides the eligible students in getting State and Central govt. Scholarships such as National Merit, State Merit, ST/OBC/SC, Minority scolarships and other government scholarships like Ishan Uday etc.

Financial assistance is granted from the Student's Welfare Fund. Such awards are made annually on receiving application from deserving students subject to availability of fund. Meritorious but poor students are chosen to avail assistance from the Ratna Nyas.

Co-curricular activities and students' association:

The Nagaon GNDG Commerce College Students Union is the General Body of the students of the college. Its membership is compulsory for every student of the college. Office bearers are elected annually. The Principal of the college is the ex-officio President of the Union Society. He has the absolute power to dissolve the elected office bearers body and to nominate office bearers under extraordinary circumstances.

The students render social services. The students' union organises various activities mainly, Games and Sports, Debates, Cultural programmes and Social Service among the students. It also brings out a magazine annually for developing the creative potentialities of students. The college is also endeavouring to set up some units/association related to Co-Curricular activities and to organise Ratna Kanta Bora memorial debating competition in state level.

Summer Project Report:

A candidates shall submit a 'Summer Project Report' herein after referred to as Report, in duplicate to the Head of the Deptt. within 5 weeks of completing of the project, generally by 15th November in the 5th Semester Period. The Report shall carry 100 marks in total out of which 20 marks be allocated for internal evaluation. The remaining 80 marks be divided into 50 marks for evaluation of the text of the report and 30 marks vivia-voce The Report shall be prepared under the guidance of a teacher of the Deptt. who shall be referred to as the Guide for this purpose. The Guide in consultation with the candidate concerned shall determine the topics & exact tile of the Report. Two examiners will be appointed by the Controller of Examinations shall evaluate each report. The average of the marks awarded by the two examiners shall be the marks awarded to the candidates on the text part of the report. The Guide & the external examiners shall conduct the viva - voca examination jointly.

A failed candidate eligible to appear in a maximum of 2 back papers in Term End Semester examination, provided he/she has secured minimum 50% marks in the aggregate in the concerned examination. A student will be allowed to clear 6 Semesters in maximum 5 years. He / she will not be allowed to take more than 3 chances in any Semester. A students who could not appear or failed in any Semester, will be allowed to clear the same as follows.

- (i) 1st Semester with the regular 3rd/5th semester.
- (ii) 2nd Semester with the regular 4th / 6the semester.

If a candidate secured pass marks in internal evaluation but has not cleared any of the Semester Examination then he / she will be allowed to appear in the next Semester examination, but his / her final results after 4th Semester, will be kept with-held until he / she clears all the back log.

If a candidate fails in a Semester Examination, the marks secured by him/her in internal evaluation in each subject, shall be carried over to the next Semester Examination, provided he/she obtains the minimum pass marks which shall remain valid for 2 years only.

Results: A candidate shall be awarded BBA Degree on passing all the 6 Semester examination. Final results will be worked out by adding up total marks secured in all the 6 Semester examination. Students getting 50% or more but less 60% in aggreagate will be declared as having passed in 2nd class & those securing 60% & above we get 1st class.

RULES OF COLLEGE DISCIPLINE

- (A) All powers of maintaining discipline are vested with the Principal and his decisions shall be final in all such matters. The students are bound by all the rules and regulations made by the College from time to time. Any matter not expressly provided for in these rules shall vest at the absolute discretion of the Principal who also reserves the right of modifying these, as and when felt necessary. Guardians are also presumed to have agreed to these rules when their wards join the college.
- (B) All the departments of the College (including library) will function according to rules made by the Principal on that behalf from time to time.
- (C) Students must observe silence in the College premises. They must not loiter in passage and corridors during class hours. Absolute silence must be maintained in the library as well as in the class-rooms.
- (D) Students must be punctual in attendance and must be on their seats at the commencement of lectures. Seat will be forfeited if a student in any semester remains absent for a long time and his or her name will be deleted from the register automatically. As such student cannot claim the seat without prior valid reason. Any leave for the student must be taken from the Principal prior to the leave. Medical Certificate must be submitted before not after taking the leave. Any representative from the family of the student can submit leave application with supporting documents.
- (E) No Society or Association of the students will be started without the permission of the Principal. The societies and associations shall be subjects to such guidance and control as the college administration may prescribe from time to time.
- (F) All notices desired to be pasted or circulated by the students anywhere in the College premises shall require the approval of the Principal.
- (G) No person shall be invited to address or entertain in the College without the previous permission of the Principal.

- (H) Subject for debate or items of entertainment by the students in the College shall first be approved by the Principal. A responsible person approved or nominated by the Principal shall be in the chair at all College debate and social functions.
- (I) To safeguard its ideal of good character and modest personal behaviour, the College reserves the right to expel any student at any time for any reason deemed by the Principal as misbehaviour in the campus of the institution.
- (J) The Principal reserves the right to remove the name of any student from attendance register for failure to pay the institute's dues in time.
- (K) Students are required to show due regard for rights and properties of the institute. Any student found guilty of tampering / damaging the property shall be punishable and may be liable to expulsion from the College.
- (L) Student must ensure that they attend their classes at least 75% without which they will not be qualified to attend the final examination.
- (M) RAGGING is a criminal offence. Any kind of Ragging is strictly prohibited both inside and outside the campus. Summary of UGC Regulations on Curbing the menace of ragging in Higher Educational Institutions, 2009:
 - i. Preamble: In view of the directions of the Hon'ble Supreme Court dated 8. 2009 and in consideration of the determination of the Central Government and the University Grants Commission to prohibit, prevent and eliminate the scourge of ragging.
 - ii. Objective: To eliminate ragging in all its forms from universities, deemed universities and other higher educational institutions in the Country by prohibiting it under these Regulations, preventing its occurrence and punishing those who indulge in ragging as provided for in these Regulations and the appropriate law inforce.
 - iii. What constitutes ragging: Ragging constitutes one or more of any of the following acts:
 - a) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
 - b) Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
 - c) Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
 - d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
 - e) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
 - f) Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;

- g) Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- h) Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
- iv. Administrative action in the event of ragging: The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here in under:
- The Anti-Ragging Committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
- The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely;
 - a) Suspension from attending classes and academic privileges.
 - b) Withholding/withdrawing scholarship/fellowship and other benefits.
 - c) Debarring from appearing in any test/examination or other evaluation process.
 - d) Withholding results.
 - e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
 - f) Suspension/expulsion from the hostel.
 - g) Cancellation of admission.
 - h) Rustication from the institution for period ranging from one to four semesters.
 - i) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
- Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
- An appeal against the order of punishment by the Anti-Ragging Committee shall lie,
 - (i) in case of an order of an institution, affiliated to or constituent part, of a University, to the Vice-Chancellor of the University; (ii) in case of an order of a University, to its Chancellor, (iii) in case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case maybe.
- Where in the opinion of the appointing authority, a lapse is attributable to any member of the faculty or staff of the institution, in the matter of reporting or taking prompt action to prevent an incident of ragging or who display an apathetic or insensitive attitude towards complaints of ragging, or who fail

to take timely steps, whether required under these Regulations or otherwise, to prevent an incident or incidents of ragging, then such authority shall initiate departmental disciplinary action, in accordance with the prescribed procedure of the institution, against such member of the faulty or staff. Provided that where such lapse is attributable to the Head of the institution, the authority designated to appoint such Head shall take such departmental disciplinary action; and such action shall be without prejudice to any action that may be taken under the penal laws for abetment of ragging for failure to take timely steps in the prevention of ragging or punishing any student found guilty of ragging. 


