





- g) USTM and NAGAON G. N. D. G. COMMERCE COLLEGE will jointly organize awareness campaigns, rallies, streetplays etc., celebrate important occasions and appreciate good works by offering felicitation to the performers from time to time.
- h) USTM and NAGAON G. N. D. G. COMMERCE COLLEGE will extend collaborative support to the people in distress during any natural calamity of the region.
- i) USTM will provide professional support to NAGAON G. N. D. G. COMMERCE COLLEGE.
- j) USTM will offer freeship / scholarship for poor meritorious students for higher education on recommendation from NAGAON G. N. D. G. COMMERCE COLLEGE authority.
